Terms and Conditions

1. LEGAL AGREEMENT

- 1. These are the terms and conditions ("Terms") that govern your use of this website and any purchase of a gift voucher ("Gift Voucher").
- 2. This forms a legal agreement between you, the user of the website and purchaser of any Gift Vouchers, and W&H THOMAS Ltd ("Seller", "we", "us", "our") and you must agree to these Terms in order to purchase a Gift Voucher.

2. ORDERING A GIFT VOUCHER

3. PAYMENT

This is typically done within two (2) working days of us confirming acceptance of your order. We cannot take responsibility for delays caused by the postal service.
- 2. If you do not receive your voucher within 14 days of our confirmation, you may contact us via the details shown on the website or in the confirmation, and we will do our best to investigate and assist.
- 3. All Gift Vouchers are non-refundable and non-transferable unless otherwise agreed by us. No cash alternative is available.
